The marks obtained by 100 candidates who duly appeared in written examination conducted (online mode) on 01.03.2026 for the Post of Naib Tehsildar Post Code 26/25 in Delhi Urban Shelter Improvement Board (DUSIB) have been uploaded on the OARS module of the Board's website. Accordingly, based on the performance in the written examination, **100 candidates** (UR-100) in the merit have been provisionally shortlisted for appearing in Descriptive Examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
