1. The DSSSB vide its advertisement No.06/24 read with corrigendum dated 14.10.2024 had advertised **Total-29 vacancies [UR-14, EWS-02, OBC-06, SC-03, ST-04 & ExSM-02]** for the post of **Driver, Staff Car Driver (Ordinary Grade) Driver LMV** under Post Code- 813/24 in Various Departments.
2. The written examination (online mode) was conducted on **09.07.2025**.
3. The marks obtained by **2309 candidates** who have duly appeared in examination (online mode) held on **09.07.2025** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dssbsonline.nic.in**
4. Based on the performance in the Tier-I written examination (online Mode), a total of **683 candidates (UR-301, EWS-36, OBC-117, SC-131, ST-90 & ExSM-08)** who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Driving Test/Skill Test Exam, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Driving Test/Skill Test Exam separately. Details as under:-

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Driving/Skill Test Exam does not entitle them any right over the post.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.
7. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidates is 40%, for OBC candidates is 35% and for SC, ST & PwBD candidates is 30% and Ex-servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%.

8. The details of Driving/Skill Test shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.
9. The above short-listing for Driving/Skill Test for the post of **Driver, Staff Car Driver (Ordinary Grade)/Driver LMV under POST CODE- 813/24 in Drugs Control Department, Department of Law, Justice and Legislative Affairs, Lokayukta, Directorate of Vigilance, General Administration Deptt., Delhi Archives & Delhi Prisons** will be subject to outcome of pending court cases, if any.
